

**BE KIND. BE CALM. BE SAFE.**

- When considering to come to Mayne Island Brewing Company, customers are asked to self-monitor their health and not come to the brewery if they are experiencing any symptoms of Covid-19 or have knowingly recently been in contact with an infected individual. If you are currently in quarantine, please call us for on Island delivery during daytime hours: 250-526-0711
- Customers are asked to wear masks when not seated and legally must show proof of double vaccination if they choose to stay and have a tasting flight.
- Beer and merchandise Off-sales do NOT require proof of Vaccination.
- Open Thursdays, Fridays Saturdays and Sundays 1-5 in winter our Customers can come to enjoy our OUT DOOR natural forest setting and consume one taster flight per person and sit in pods of up to six persons at one table.
- You can bring a snack or some lunch to enjoy with your beers.
- Staff will wear Personal Protective Equipment when necessary- and use steriliser on touch points and hands between customers.
- The on-site store/tasting room will provide a take out window and serve patrons out doors. We will not have indoor seating available at this time.
- At every stage of production through to the delivery to the customer every glass/taster tray or bottle of our product will be handled with proper use of protective equipment of Masks and sanitised hands offering up a sterilised product.
- 4 Hand sanitation stations will be available for staff and customer use.
- Frequent Touch points such as railings and door handles will be sanitised on a per use basis whenever possible and will be cleaned hourly if this is not possible.
- Two portable toilets plus a wheelchair accessible bathroom are available for customer use and have hand sanitation and sanitation spray and wipes available with instructions for customers to sanitise before and after their use of door handles, toilet seat, etc.
- When looking at clothing and merchandise customers are asked to sanitise hands before and after touching hangers or products. Please do not try on hats, shirts or hoodies at this time. If the product has had any more extensive handling, we will quarantine it for 5 days before hanging back on the rack.
- Patrons are asked to stay seated while drinking and not to wander outside of the designated picnic area and not stand too close to other tables talking with patrons outside of their bubble.
- Physical distancing measures of 2 metres must be adhered to by staff and customers except for those persons within a pod of up to 6 persons.
- We ask patrons with children to stay within reach of their charges at all times to help reduce touch point contamination and reduce close contact with other patrons and staff.
- We will post this Covid-19 plan at the brewery and ensure that a copy of this plan is available to the public via our website and social media platforms.
- We reserve the right to refuse customer service at any time for any reason that may not adhere to this Covid-19 plan.
- We will have strict health monitoring of staff and report any and every sign of possible contamination to proper health authorities.
